Assumption of Risks

I, _____, acknowledge that I have voluntarily signed up to go on a Living Morocco trip which is designated by me on the Application form. I am traveling to Morocco on this itinerary with knowledge that going to this country and/or remote areas involve numerous risks and dangers including, but not limited to, the forces of nature; civil unrest; terrorism; roads, trails, hotels, homevisits, vehicles or other conveyances which are not operated or maintained to standards common in the United States; high altitude; accident or illness without access to means of rapid evacuation or availability of medical supplies; the inadequacy of medical attention once provided; physical exertion of which I am not prepared; or negligence (but not willful or fraudulent conduct) on the part of Living Morocco, Inc., or others.

This agreement sets forth the entire agreement of the parties and may only be changed or provisions waived by a writing signed by both parties.
